#### Project Reference and Title

To lower the entry barrier to IT Investments for SMEs in Retail, Wholesale, and Distribution Industries through independently tested and evaluated Cloud Applications (D10 004 007)

#### Project Summary (in not more than 150 words)

For SMEs, it is widely agreed that the use of IT will certainly help make their operations more efficient. However, their IT adoption has been low because they lack the capital to invest in, and the knowledge to purchase, operate and maintain an IT system.

The recently available "cloud-based applications" will lower the entry barrier for SMEs to adopt IT. "Cloud-based applications" are computer applications that are hosted in the "Cloud" or Internet. Users no longer need to have the expertise to install and maintain the software system nor are they required to set up costly computer servers in the office to host the applications. SMEs can now use these cloud-based applications by accessing them through the Internet on a monthly fee basis. With the "pay-per-use" business model of cloud computing, SMEs no longer need to pay a hefty upfront cost to purchase the computer hardware and software. Thus, with cloud computing, useful IT applications such as Customer Relationship Management (CRM), Human Resources and Payroll can be made available to SMEs through Internet access at a relatively low cost.

However, as cloud computing is still new to many SMEs, they either do not understand fully what cloud computing is, what it can do, or worry about the performance of cloud applications. In addition, they lack a reliable and independent source of information on cloud applications/services, based on upon which, SMEs can make a decision on if and what cloud solutions will benefit their operations.

To tackle this problem, the SME Global Alliance proposes to initiate this project to carry out a Cloud Solutions Testing & Evaluation Programme to address the concerns of SMEs. An information database and knowledge bank of field-tested cloud solutions will be made available for SMEs. The focus will be on solutions for the Retail, Wholesale, and Distribution Service sectors, which comprise over 50% of all SMEs, are among the most competitive fields, and have relatively low IT adoption rates among all businesses in Hong Kong. The results of the programs will be disseminated through seminars, project website and other related channels free of charge.

### Project Objective(s) (in not more than 80 words)

In response to the pressing needs of SMEs, the major objectives of this Cloud Solutions Testing & Evaluation Programme is to:

- Raise the awareness of SMEs in the Retail, Wholesale and Distribution Service sectors in cloud services/solutions;
- Enable the target SMEs to identify a right cloud service/solution easily;
- Encourage the adoption of cloud services/solutions in order to lower the IT investment of the target SMEs; and eventually,
- Enhance the IT capability of the target SMEs in order to streamline their operation and enhance their competitiveness.

# 1. Test and evaluation of cloud solutions

- 24 cloud solutions for SMEs in the retail, wholesale and distribution service sectors were tested and evaluated.
- The results were published in the guidebook "香港中小企業雲端方案應用指南", available in print (3,000 copies) and as electronic copy for download on the project website.

#### 2. Promotional seminars

- 3 half-day seminars were organised to promote the project and disseminate the project results.

#### 4. Publication of Guidebook

- The guidebook "香港中小企業雲端方案應用指南" was published in Nov 2012, containing practical tips on how to evaluate and choose cloud solutions according to an SME's business needs, and an evaluation of the 24 cloud solutions to serve as examples illustrating to SMEs how to choose the right cloud solution.
- 3,000 hardcopies as well as a softcopy of the guidebook were made and distributed through websites and other marketing channels.

The project website (<u>www.sme-cloud.org</u>) was created, containing project and event information, seminar photos and presentation files, as well as the test and evaluation results in the guidebook.

The project has contributed to enhancing the competitiveness of Hong Kong's SMEs by introducing the benefits of cloud computing to the target SMEs and educating them on how to choose the right solutions to realize the benefits. According to the survey results of the 3 seminars and 4 workshops, on average 92.84% of the respondents indicated that they will apply the recommendations provided in the seminars/workshops in their daily business operations.

The beneficiaries participating through project activities include participants to seminars and workshops (548) and those reached through database marketing, distribution of the Guidebook, on-line channels and advertisements (over 60,000).

Through the guidebook, the SME beneficiaries gained important insights on what specific features and parameters they should pay attention to in selecting cloud solutions, which help them evaluate and choose cloud solutions suitable for their needs. The guidebook lists out the evaluation parameters in a clear format and offers 24 example cases to illustrate the evaluation process.

The project attracted media coverage, reaching a wider audience to receive benefits from the project. This included 2 pieces of news about the project found on Hong Kong Commercial Daily (4 Dec 2012) and Ming Pao Daily News (8 Feb 2013). The project was also featured in the HKPC publication *Industry Focus* (Feb 2013).
