Project Summary (in not more than 150 words)

This project is concerned with the design and launch of a support program aimed to provide practical knowledge and operational practices in handling high value goods logistics services to SMEs in Hong Kong in order to enhance their knowledge level and logistics capabilities. Through organizing a series of seminars and workshops, these operational practices of high value goods logistics services are explained and delivered with illustrated cases in detail. Sets of booklets and DVD-ROM are distributed to both participated and other SMEs in general. In addition, project information and booklets contents are posted on the website tailor-made for this project. It is expected that Hong Kong's SMEs can benefit from this program so as to strengthen their capabilities in handling high value goods logistics services.

- 1. To design and launch a support program which is able to enhance the knowledge level and provide relevant operational practices in handling high value goods logistics services to SMEs in Hong Kong for enhancing their logistics capabilities.

Methodology Employed

The methodology employed was divided into five stages as follows:

Stage 1: Formation of Project Team

A steering committee was formed to provide direction and monitor the whole project process of good quality. Members of the steering committee include Mr. Stephen Chan (from Hong Kong Logistics Association), Dr. Stephen Ng (from The Institute of Purchasing & Supply of Hong Kong), Mr. Timothy Lam (from The Institute of Purchasing & Supply of Hong Kong), Dr. Michael Li (from Hong Kong Institute of Engineers), Dr. George Ho (from The Hong Kong Polytechnic University) and Dr. Nick Chung (from The Hong Kong Polytechnic University). Moreover, key project team members were recruited successfully through an open and competitive system.

Stage 2: The Background Study

Literature review studies and site visits were conducted in order to clearly define the theme scopes and content of high value goods logistics services within the support program. Project team members interviewed and conducted site visits to various companies such as HugoBoss, Loreal, Crown Logistics, Jebsen Logistics and Unique SCM (HK) Ltd, in order to get better understanding about the real practices of high value goods logistics services. After site visits, the logistics practices and approaches were recorded as useful materials for preparing the content of booklets.

Stage 3: Production of Booklet

Contents of high value goods logistics services for the four specific sectors were compiled after the topics had been determined and the background study and site visits to logistics service companies had been conducted. Content of the booklet were prepared accordingly for the seminars and workshops.

Stage 4: Promotion of Project Deliverables

Two seminars and four training workshops were launched successfully. Logistics experts were invited to these events to spread the knowledge and real practices of high value goods logistics services to the management staff of SMEs in general who participated in the project activities.

Stage 5: Production of DVD-ROM

6,000 sets of DVD-ROM were produced. Each set of DVDROM consists of:

- soft copies of the booklet, related materials used in the seminars and workshops, and other project information:
- videos of the highlights of seminars and workshops or interviews.

1 Rooklets

A set of booklets in Chinese on the four topics, including (i) A consumer product regional distribution hub providing electronic parts, components, etc., (ii) Fine wine storage and transportation, (iii) Prestige branded fashionable goods local and regional logistics hub, and (iv) Establishing consolidation, de-consolidation, and cross docking centre for high value products, were developed.

2. Seminars

Two seminars were launched as follows:

(i) First seminar:

- Topic: Roles and Opportunities of Hong Kong as the Supply Chain and Logistics Centre of High Value Goods (Fashionable goods, consumer electronics and logistics consolidation)
- Date: Oct 17, 2013

(ii) Second seminar:

- Topic: Characteristics, Storage and Transportation of Fine Wine and Establishing Cross Docking Centre for High Value Products

Case studies of different industries including retail, cosmetics, high value fashionable brand, fine wine, information technology and third party logistics, were introduced in seminars. Logistics experts from selected companies were invited to share their experience to SMEs in general. Over 460 management staff of SMEs in general has attended the two seminars.

3. Training Workshops

Four training workshops were launched as follows:

Case studies of different industries involving fine wine, fashionable goods, skincare and cosmetics, air freight, and logistics were introduced in training workshops in order to help SMEs in general enhance their operational practices in handling high value goods logistics services. Over 465 management staff of SMEs in general has participated in the four training workshops.

4. DVD-ROMs

The booklets content, related materials used in seminars and workshops, and other project information and videos of the highlights of seminars and workshops were included in DVD-ROMs. 6,000 sets of DVD-ROMs (1 disc per set) were disseminated through Hong Kong Logistics Association, The Institute of Purchasing & Supply of Hong Kong and the Department of Industrial and Systems Engineering of The Hong Kong Polytechnic University. Through the DVD-ROMs, more general SMEs can learn various logistics operations in handling high value goods that are most suitable for the operation environment in Hong Kong.

5. Website

A project website was set up for the enrollment of seminars and workshops as well as disseminating contents and the booklets of the four topics that are easily accessed by SMEs in Hong Kong. The project website can be accessed through http://highvalue.logistics.org.hk.

Over 925 management staff of SMEs in different industries participated in our high value goods logistics project events during the project period. Over 460 management staff of SMEs in general has participated in the two seminars. Over 465 management staff of SMEs in general has attended the four training workshops.

In order to collect feedback from the participants, a questionnaire was conducted during each project activity. We have collected a total of 401 completed questionnaires from the participants of all our project events. From the results, 86% of the questionnaires respondents thought that the project events were very useful or useful in enhancing the competitiveness of Hong Kong's SMEs in general. In addition, 91% of them were very satisfied or satisfied with the overall performance of the project events.

| According to the feedback from the participants of SMEs in general during each activity, it is shown that participants learnt various essential logistics knowledge from our seminars and training workshops. Deliverables of this high value goods logistics project (D12 001 002) provide essential assistance in the form of sharing relevant logistics knowledge for them to enhance daily operational effectiveness and competitiveness. Moreover, it is proved that experiences sharing from selected companies by means of seminars and training workshops are valuable to the participants (Hong Kong's SMEs in general) in the formulation of logistics strategies and action plans in handling high value goods logistics. |
