Based on the genuine need of the SME catering to handle their liability risk, with the PEAK as the implementation agent, the Institution of Dining Art Ltd (IDA) successfully applied for the SME Development Fund and carried out smoothly the establishment and propagation of "Liability Risk Management & Business Continuity Scheme in SME Catering" (LRM) form 1 Mar 2014 to 31 Mar 2015. The LRM Project included 2 seminars, 6 workshops and 5,000 manual books, provides solutions and services to educate the catering liability risk management process including identification, control and the development of a proactive disaster recovery contingency planning to sustain business continuity.

Methodology Employed

The IDA invites the Institute of Professional Education And Knowledge (PEAK) as the implementation organization, which will provide consultancy services and the production of project related activities. With the support of the SME Development Fund, joint effort of two organisations contribute to the knowledge of the SMEs to handle their liability risk management including emergency crises and recover business activities.

As the project's implementation agent, PEAK leverages its experience in the coordination, liaison and control of various functional units within the project, which includes identification of key technologies, seminar management, handbook development and website maintenance. Its responsibilities also include the production, promotion and marketing of the project including the seminars, workshops and manual; appropriate allocation and utilisation of resources; monitoring progress, inviting and assimilating comments of the project, assurance of output quality and its cost effectiveness. It works according to the following operation plan:

- 1) Formation of consultation committee
- 2) Project website construction
- 3) Working on project deliverables and promotion activities
- 4) Conduction of reporting, reviewing, and further exploration, etc.

The <u>ePortal site http://riskmgt.smecatering.hk/</u> was launched at the early stage of the project and is now running by IDA free to provide online download of the powerpoint teaching notes of the seminars and workshops, and the leaflets for the essential information and basic knowledge as below:
 - (a) relevant legal documents SME caterers should know;
 - (b) best practices in handling risks;
 - (c) updates on newest development on SME liability risk management catering issues;
 - (d) real life examples;
 - (e) Work cards or info cards readily available for use;
 - (f) Liability Risk management and/or relative insurance solutions available on the market;
 - (g) Contingency and Disaster recovery program and its procedures.

2. 2 seminars and 6 workshops with details as below:

Experienced practitioners will be invited for speakers in seminars and workshops mainly from IDA together with the various supporting organizations representing the sectors of catering, insurance and risk management to enable the SME caterers to identify and handle their liability risks, to provide an interactive platform to acquire the risk control and business continuity procedures, making reference to the risk management systems or manuals adopted by large corporations and the views of insurance companies with various themes as follows:

- i. The first seminar [識責任、控風險、樂安營] 研討會 was held on 26 June, 2014 with 95 attendees.
- ii. The first series of workshop [明責任、移風險、樂安營] 工作坊 was held on 19 August, 25 August and 16 Sept. 2014 with attendees of 60,51 and 43 respectively.
- iii. The second series of workshop [辨責任、控風險、倍安心] 工作坊 was held on 21 Oct, 19 Nov. and 9 Dec. 2014 with attendees of 53,53 and 51 respectively.
- iv. The closing seminar [勇謀兼備,化險為易] 研討會 was held on 26 Mar. 2015 with 121 attendees.
- 3. <u>5,000 copies of [中小企餐飲業責任風險管理及業務持續運作手冊]</u> and <u>2,500 leaflets for quick references.</u> The Manual cover:
 - i. Liability Risk Management ABC for SME catering;
 - ii. Liability Risk Self-assessment Working Manual in step-by-step approach;
 - iii. Business Continuity planning.

The Manual can also be available in our ePortal and be compiled with user friendly approach together with attractive and easy understanding diagrams, flowcharts, etc.
