Project Summary (in about 150 words)

The sales techniques being practised in the natural fei cui and jade industry are drastically different from those used to sell traditional commodities. Presently, one of the biggest problem in the industry is the challenge created by the newly amended ordinance towards the traditional sales techniques. Disputes between the customers and the salesman due to different understanding to the newly amended ordinance have been happened several times lately. Consequently, the front line sales personnel is very frustrated, though no one has been prosecuted yet. Therefore, proper guidelines and trainings must be provided to avoid any unnecessary violations of the ordinance.

Hong Kong & Kowloon Jade Merchants & Workers Union Association Limited (HKJMWA), with PEAK as the implementation agent, successfully applied for the SME Development Fund and carried out smoothly the project "Action plan for the Natural Fei Cui plus other Jade industry in compliance with the Trade Descriptions (Unfair Trade Practices) (Amendment) Ordinance" from 1 July 2015 to 30 June 2016. The project has organised a series of workshops, seminars, symposium as well as website and guide book to achieve the objectives of the project.
